## **AHCA's ESS: Reporting Updates - Nursing Homes and Assisted Living Providers**

Pursuant to Governor Ron DeSantis' Executive Order 20-51 and at the direction of State Surgeon General Rivkees, regarding Novel Coronavirus (COVID-19), the Agency for Health Care Administration opened the event "COVID-19 Monitoring" in the [Emergency Status System](#) (ESS) to monitor health care provider census, inventory, needs, and other related information statewide.

### **ESS Update for Nursing Homes and Assisted Living Providers**

Effective today, June 30, 2020, the event tab labeled "Add'l Info" has been updated. The ESS will now require entry of fields related to your facility's Curative testing status.

Please answer all that apply to your facility and be sure to answer the remaining questions daily by 10 AM ET. The [Long Term Care Facility Additional Info Entry - Questions Guidance](#) has been created to provide additional guidance for reporting correctly.

### **All Long Term Care Facilities**

- The "Add'l Info" tab should be updated **daily by 10 AM ET** until further notice.
  - Questions on this screen may vary so be sure to read carefully each time you go to enter info.
  - You may view previous responses by using the "History" table at the bottom of this screen.

Please report Current Resident Census and available beds in your facility daily by 10 AM ET until further notice.
