### **ESS Reporting**

Effective February 16, 2021, the "Add'l Info" tab has been updated to specify the number of current staff and residents that have and have not received at least one dose of the vaccine. The questions have also been revised to remove those no longer needed, reducing the number from 30 to 14 questions.

Please continue to report the current Bed Census and Available Beds and the Add'l Info tabs **daily** by 10 AM ET until further notice.
